JOINT STATEMENT OF CHAIRMAN WAXMAN AND RANKING MEMBER DAVIS

Washington, DC — Today the Oversight and Government Reform Committee is issuing a subpoena for Chuck Knoblauch to appear at a deposition regarding allegations in Senator George Mitchell's *Report to the Commissioner of Baseball of an Independent Investigation into the Illegal Use of Steroids and Other Performance Enhancing Substances by Players in Major League Baseball*. Chairman Waxman and Ranking Member Davis issued the following statement:

“The Committee has taken this step because Mr. Knoblauch failed to respond to the invitation to participate voluntarily in a deposition or transcribed interview and the February 13 hearing.”
